Perform a Quick Response to Defend Performance, Elnusa Shares Dividend Rp37 Billion

Jakarta, May 14, 2018 - PT Elnusa Tbk (Elnusa), a reputable energy services company, closed its fiscal year 2017 with a net profit of Rp247 billion.
