Intensively Improving the Quality of Archives Services, Elnusa Achieves AA Archives Accreditation

Jakarta, 21 December 2023 – PT Elnusa Tbk (Elnusa), through its subsidiary PT Sigma Cipta Utama (SCU), which operates in the field of data management and ICT (Information, Communication & Technology) services, received AA (special) accreditation which was handed over symbolically by Acting Head of the National Archives of the Republic of Indonesia (ANRI), Imam Gunarto. The presentation of the archival accreditation certificate was carried out in a hybrid manner at the Gran Melia Hotel on (15/12), Jakarta.

In 2018, SCU received A accreditation for archives from ANRI and became the only company providing archival services to receive A accreditation. Then at the end of 2023, SCU again succeeded in improving the quality of archival services by achieving AA (special) predicate, this proves that SCU continuously improves the quality of archival services. ANRI as a non-ministerial government institution which has the authority to issue archival quality certification in the process of assessing and supervising archives administering institutions such as SCU, always applies dynamic methodologies and strategies to adapt to current developments.

Acting Head of the National Archives of the Republic of Indonesia (ANRI), Imam Gunarto, in his speech said that the archival accreditation certification activities and assessment of the results of archival supervision in 2023 are related to the government's efforts to guarantee the quality of archival organizers from the coaching to supervision side, including certification and accreditation. The results of accreditation are used as a benchmark to see the quality of performance of archival institutions that are participatory or mandatory in nature.

SCU is an institution that provides warehouse and data management services in the form of storage services such as tape storage, document storage, core storage, general asset storage, and data transcription services. For this reason, in order to maintain archive services at the best standards, the main step is to implement standard warehouse and data management regulations and obtain certification for archive management standards, one of which is from ANRI.

Adi Yatama Adi Guna as Director of SCU said, "SCU is a non-governmental organization providing archival services in the field of archival storage which has received AA qualification from ANRI. This achievement is extraordinary considering that the impact will be very positive on the warehouse and data management business competencies at SCU, now and in the future. "This is also a main indicator in realizing SCU's vision as a market leader in archival and data management services," said Adi.

Adi added, "The archival qualifications provided by ANRI with AA accreditation make SCU even more confident in continuing to compete to provide the best standards of archival & data management services to all stakeholders and at the same time can become a role model for institutions providing archival services, especially in the oil and gas industry," concluded Adi.
